OFFICE ORDER

Sub: CWP No. 5789 of 2011 titled Asif Masood & 11 others Vs HIMSR and Jamia Hamdard pending before the Delhi High Court – Restoration of Grade Pay of Rs.2800/- to Laboratory Technician (Junior Scale)

This has reference to Office Order D.No.Estab/LD/148 dated 19.5.2011 issued by the Registrar under which a lower grade pay of Rs. 1800/- has been prescribed for 16 incumbents holding the position of Lab Technician (Junior Scale) in the HIMSR/HAHCH Jamia Hamdard on the grounds with retrospective effect from their date of joining (copy enclosed).

2. The matter has been reviewed in view of the orders dated 01.06.2023, 01.04.2024 and 20.08.2024 by the Hon'ble High Court of Delhi in CWP No.5789 of 2011 filed by 12 Lab Technicians (Junior Scale) aggrieved by the aforesaid office order dated 19.5.2011 by the Vice-Chancellor of the Jamia Hamdard. Based on the recommendations of the Committee constituted by the Vice-Chancellor on the above matter, the grade pay of Rs.2800/- in PB 2: Rs. 5200-20,200/- has been restored in respect of the following 16 Lab Technician (Junior Scale) of HIMSR/HAHCH Jamia Hamdard: -
