ORDER

Whereas a disciplinary proceeding against Dr. M.S. Kidwai, Addl. Medical Superintendent, Hakeem Abdul Hameed Centenary Hospital, Jamia Hamdard & In-charge, HR, Hamdard Institute of Medical Sciences/HAHCH is contemplated for alleged misconduct and insubordination of orders of his superiors and the authority body viz. Executive Council and the statutory officers of the Jamia Hamdard.

Now, therefore, the Vice-Chancellor of the Jamia Hamdard, in exercise of the powers conferred by bylaws/MOA and UGC (Institutions Deemed to be Universities) Regulations as amended from time to time read with sub-rule (1) of Rule 10 Central Civil Services (Classification, Control and Appeal) Rules, 1965, clause 65 of the Jamia Hamdard Calendar read with the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018 as applicable to teachers of Jamia Hamdard, hereby places the said Dr. M.S. Kidwai under suspension with immediate effect i.e. 12.11.2024 (AN), pending departmental enquiry.

It is further ordered that during the period that this Order shall remain in force the HQrs of Dr. M.S. Kidwai, Addl. Medical Superintendent, Hakeem Abdul Hameed Centenary Hospital, Jamia Hamdard & In-charge, HR, Hamdard Institute of Medical Sciences/HAHCH, Jamia Hamdard shall be the Office of the Registrar and he shall not leave the HQrs without obtaining the previous permission of the Vice-Chancellor.

Orders regarding subsistence allowance admissible to him during the period of his suspension will be issued separately.
